### ARIZONA STATE LAW JOURNAL

The Arizona State Law Journal is the flagship law journal at the Sandra Day O'Connor College of Law. The purpose of the Arizona State Law Journal is to produce, edit, and publish high-quality works of legal scholarship. The operational and editorial functions of the Journal are managed by our student members. For those eligible, the Journal provides one of the finest available avenues for advancing legal education. Its work contributes to each student's intellectual advancement, the development of law, the legal profession, and the stature of the College of Law.

The *Journal* publishes at least four issues each year, featuring articles written by top scholars, as well as student-authored works on cutting-edge areas of the law. Students who are selected to serve as Staff Writers during their second year have the opportunity to become Editors during their third year. *Journal* membership is highly respected by employers, and it is often considered a must for students who wish to obtain a judicial clerkship or enter academia.

Each year the *Journal* invites 32 students to join. The 15 highest ranking 1Ls are sent an invitation, and the remaining 17 students are chosen through the Write-On Exam. The Exam includes a closed-universe memorandum and a *Bluebook* citation quiz which consists of approximately 50 multiple-choice questions. The breakdown for the Write-On Exam score is 45% GPA, 25% written problem, 25% *Bluebook* quiz, and 5% legal writing grades.
